Manager earns 30% of realized trading profit; 50% of that earned Manager Fee is allocated across Levels 1-15.

LOCKED CALCULATION RULES

- 1. Distribution pool = realized Manager Performance Fee × 50%; investor principal/deposits are never used.
- 2. A reward is created only from an actually earned performance fee; no guaranteed or fixed return is promised.
- 3. Missing, inactive or otherwise ineligible upline levels are skipped and the system checks the next eligible level in sequence.
- 4. Monthly settlement uses realized/confirmed fees only; each source-fee + beneficiary + level can be paid once.
- 5. All amounts are rounded to 2 decimals; total payouts can never exceed the 50% Manager-Fee pool; rounding residual stays with the Manager.
- 6. No reward is generated solely for registration, recruitment, deposit size, referral count or account opening.

MONTHLY SALARY

Salary is based on the total business generated by the team during the month. Business Split Rule: Maximum 50% from one leg; the remaining 50% from other legs.

Monthly Reward

Only New Business for the entire month will be calculated. The reward will be credited after one month.

Example: If \$10,000 of business is generated from January 1 to January 31, the reward will be credited between March 1 and March 5.

Eligibility: At least 2 active direct members are required.

Business Split Rule: Maximum 40% from one leg; the remaining 60% from other legs.

Total Business must be maintained in the following month. If business is withdrawn or reduced, the reward and salary may lapse.

AUTO UPGRADE / AUTO DOWNGRADE



Millionbux4u has fully automated level management.

Auto Upgrade: When the requirements for Active Direct Team, Team Business Volume, and Self Balance are fulfilled, the level will automatically upgrade.

Auto Downgrade: If Team Business or Self Balance falls below the required limit, the level will automatically downgrade or pause.

There is no manual approval. There is no permanent level. All levels are dynamic.

IMPORTANT NOTE

Total Business must be maintained in the following month. If business is withdrawn or reduced, the Monthly Reward and Salary will lapse.
